# 4. PRESENTATION: Freedom of Information Protection & Privacy Act (FIPPA) (Alisha McKinnon)

- (presentation can NOT be distributed)
- FIPPA provides individuals with the right to access **records** held by the Ontario Government subject to specific exemptions.
- FIPPA ensures the protection of personal information, and some sensitive business information held by the Ontario Government.
- If in doubt, don't give it out
- If LCC receives a request for records of the committee or a committee member, advise MNRF rep immediately
- A privacy breach occurs when an individual's personal information is not collected/used/disclosed/retained or destroyed in compliance with FIPPA.
- Paul asked if there is any monetary penalty for privacy breaches
- Alisha will provide information back to the LCAC

#### **5. RE-OCCURRING BUSINESS**

a) Wabigoon Forest – (Daniel Y.)

#### • Domtar Operations:

- o Two Chippers are in Turkey Trail and Lonehand Roads blocks BL87 and BL90.
- One buncher is in Suzanne Road block BL67 and two bunchers are in Lonehand Road block BL86.
- Two back hoes are in block BL67 on Suzanne Road. There will be gravelling in this block with a rock truck.
- One back hoe is currently in block BL90 off Avery Lake Road. Fixing of plugged culverts along Bear Narrows km 4, 6, 7 will occur, as well as pulling winter crossing from block 2557.
   There will be upgrading of Twin Grass Road.
- Future conifer wood flow continues to be chipped in the Lonehand/Turkey Trail area, and hardwood to be harvested from Twin Grass in the next month and potentially at Spawning Road.
- o Site preparation is currently in Bunyan area.
- Tree planting is ongoing in the Basket Lake and Cooks areas.

## Resolute operations:

- One chipper and processor on Gilbert Road in block GW147– focusing on saw log and chipping haul.
- Buncher and Forwarder in block RA255 Raleigh Cutoff.
- English River haul is coming through the Basket Lake Road and hauling by DFMC is coming through the North Road.
- Gravel haul is working for the NWMO (Nuclear Waste Mgt Organization), but are accessing the Tower road, to the Dyment road.

#### 2019-2029 FMP Update

The Aerial Herbicide Plan (AWS (Annual Work Schedule) revision 001) and Scheduled
 Establishment Assessment Layer (AWS revision 002) are submitted to the MNRF for review

- Working on AWS revision 003 for submission (June) to the Dryden District deals with changes to water crossing (e.g., WC 0838), addition of block LB213 and some values updates.
- Q Darrel where is Twin Grass Road A west side Contact Bay
- Q Darlene –asked who cut wood in MTO gravel pit chipping wood to Domtar, other wood to Resolute. Path of the Paddle Portage is gone from where it was. This is MTO not MNRF jurisdiction.

- Wildlife trapped two orphaned bear cubs, sent to rehabilitation Bear with us site can see bear cub video https://bearwithus.org
- Eagle retrieved (hit by vehicle) sent to rehabilitation facility in Kenora (deceased, sent away to toxicology center – possibly fed on animal that was euthanized)
- Raven sent away believe West Nile (4 ravens all dead after drinking water from horse water trough)
- Baby martens sent to rehab in Kenora
- Moose (found deceased Snake Bay) testing for brainworm
- Completed transition endangered species act to MECP (kept related to FMP)
- Q any rules governing disposing of euthanized animals (Ministry of Agriculture)
- A Euthanized animals are supposed to be buried
- Q re Bearwise A we don't actively trap, process (4 points need to be met) will deploy traps
