- 2 Backhoes are working on Cooks/Bumblebee roads and 2 Skidders working in block
 LB209 on Upper Manitou road
- 2 Chippers, 2 Backhoes and 2 Bunchers are working in Hudson Cutoff/Centrefire- block
 GW139
- A Buncher, Dozer and Backhoe are working on Larson Lake road
- o Gravel Crew/Backhoe are operating on Bear Narrows road, hauling from km 19 pit
- Mechanical site preparation by Dorsey contracting occurring in block RA 250 on Little
 Raleigh moving to Basket Lake later this week to block BL67 and BL 66
- Mechanical site preparation occurring in block 1859 on Laval Road moving to Lens road block 1885 later this week
- Annual Work Schedule revision#2 approved by MNRF deals with addition of harvest blocks and water crossing updates
- 3 FMP Amendment requests submitted for amendment classification- includes ORB changes, Road Use Management changes, addition of Aggregate Extraction Areas, Hardwood management strategies, AOC prescriptions updates

Resolute operations:

- A Buncher/Backhoe working for Resolute in blocks RA247, RA248, RA249 on Greenheart road
- 2 Bunchers/Dozer working for Resolute in block RA268 on Gord's road and a buncher working in block RA273 off Hwy 622

Amendments:

- Amendment requests and information previously emailed to LCAC members to review prior to meeting.
- Amendments 2 and 4 require recommendation of classification (administrative, minor or major) from LCAC to District Manager
- Amendment 2 Operational Road Boundary (ORB), road use Management Strategy (RUS), mapping corrections for renewal and tending and addition of Aggregate extraction Area to allow establishment of gravel pit area for road construction.
- Amendment 4 amend the text of the 2019-2029 Wabigoon FMP to include a hardwood utilization strategy (allows portions of hardwood component to remain standing) into the current FMP due to issues being experienced with being unable to sell their product to existing suppliers due to age and size of wood.
 - Discussion on Amendments

- Q) Penny asked re amendment 4 amendment in last plan also (hardwood markets not presently poor)
- A) Daniel Y. Kenora mill shut down, wood young or too small, hard time to sell
- A) Julie bit of both, mills are full. Hard time selling smaller poplar to Weyerhaeuser. Hardwood market poor as mills are full.
- Q) Stephen any possibility of going back to get the hardwood if market improves
- A) Daniel Y. will be first prioritized to be harvested
- Q) Pierre with a shrinking market is Weyerhaeuser being pickier?
- A) Julie inventory not huge last year, they are just being pickier
- Q) Darlene re small diameter hardwood Barren Brook Road young red pine cut and left km 27, km 31 hardwood too small. Is this amendment the result of hardwood present fmp regulations Resolute hardwood strategy.
- A) Julie on the ground and bundled utilized to specs of each mill (Barren Brook).
- Q) Stephen long term effect on forest will it affect future planting of softwood?
- A) Daniel Y. if market picks up, wait and see
- A) Julie overall intent is that it isn't defer whole stand, con/mix hardwood small, allow more regeneration to happen
- A) Derek 3-5 years assess silviculture move towards desired condition, can be adjusted
- Q) Darlene birch and poplar very important for wildlife
- A) Daniel Y. maintain higher level of hardwood for wildlife
- Q) Del do you see a lot of these small blocks, could you not wait 8 more years and then harvest
- A) Julie we are already doing that. Difficulty SW and NE ends of licence. More difficult terrain, shallower soils. Too much to defer.
- A) Derek requires amendment and consultation to go with it
- Q) John does Domtar use hardwood
- A) Julie no, in process to try to incorporate some
- Q) Pierre NE corner, to go back for a few blocks would be costly
- A) Julie yes
- Q) Darlene aggregate on Bear Narrows Road old or new pit / any red/white pine
- A) Julie new pit jackpine, spruce and birch
- Q) Darlene chart for road, 2019 road class, appendix 2
- A) Daniel Y. old roads strategy, decommission or go back to land base
- Michelle stated this is a lot of information to review, Stephen could you work with LCAC committee tomorrow and then provide MNRF with recommendation
- Stephen responded we can deal with this tonight
- Paul, agreed, no objections
- Q) Darlene table 4 in amendment Beaver Road DF requesting to AOC crossing cliffs, high rock bluffs don't harvest on cliff etc.
- A) Penny same area as last year, just did not get harvested
- A) Julie either blast thru rock or go closer to lake, opted to not blast close to lake, bypass rock to obtain wood on other side. On the whole Wabigoon Forest, no roads on west side of licence, limiting access to west end.
- Q) Gord not familiar with road where is it located
- A) Julie Century Road travel to very end of road, keeping right all the way

- Gord does have an issue with that, preserving remoteness of some areas (Eagle Lake)
- Amendment is not about harvest blocks (already approved in FMP, road corridor already approved) – only amendment is the water crossings
- Penny suggested you can put forth a public comment if you disagree
- Earla stated need to be aware "not going to harvest this year", then "but it's already approved"
- Penny it is approved. AWS is where it gets approved.
- Pierre Domtar trying to do what makes sense, MNRF will not let them just do what they want, science is backing it up.
- Michelle be aware of what is going into a ten-year forest mgt plan. LCAC needs to provide classification – minor vs major.
- Stephen asked Michelle to explain major/minor amendment
- Michelle stated the flow chart that was emailed out Diagram of Amendment Category Factors explains admin/minor/major
- Dave elaborated, minor amendment 15 days to review and provide comments.
 Major 30-day notice for Info center then 30 days after to provide comments.
 Depends on complexity, severity of change to harvesting operations.
- Paul Administrative does not require a lot of consultation.
- Michelle stated you can have Administrative enhanced with public consultation
- Q) Stephen Amendment #2 closing 219 km of road.
- A) Derek errors were made in text, roads were never intended to be permanent.
- Q) Paul asked DJ if all of these are Administrative
- A) DJ a hardwood strategy of not harvesting the poplar would have an impact on achieving the LTMD, therefore this amendment should not be considered as an administrative amendment.
- Q) Del asked how public notification is handled on Minor with no local newspaper
- A) Michelle, if a minor still advertise in Sioux Lookout, Thunder Bay, papers that are available, social media same as we have been doing. Mail out to stakeholders.
- Regarding classification of Amendment 2 ORB's, 2 water crossings, aggregate extraction:
 - Penny suggests administrative, if any resource users that are in area, get contacted
 - Stephen asked does everyone agree?
 - Darlene believes it should be a minor
 - Daniel M. agrees with Darlene, minor
 - Earla minor
 - ➤ Gord minor
 - ➤ John minor
 - ➤ Paul minor
 - ➤ Del minor
 - Pierre minor
 - ➢ Ron minor
 - Stephen minor
 - Penny is good with amendment being a minor

- Amendment 4 hardwood strategy
 - Penny minor, concern if public will know what is meant unless explained further
 - ➤ Del minor, possibly major, if trees were allowed to sit beside a road and rot bad to the public, spray later also bad, re-harvest forest, early in this ten-year plan
 - ➤ Gord visuals not so good, would like to get more info on this minor
 - ➤ Darlene good to defer harvest of hardwood minor herbicide use
 - ➤ Earla minor
 - John minor, concern over effect of long term of forest
 - > Pierre minor best strategy for hardwood situation (rather than decay etc.)
 - ➤ Daniel M. minor
 - ➤ Ron minor
 - ➤ Paul minor
 - Stephen minor, happy to see hardwood left standing instead of rotting, public should be notified if any herbicide used. Review amendment and change in strategy down the road (report) success of hardwood. Any issues?
- Penny very good point could do a field visit to view the outcome
- Michelle thanked all for their input
- Darlene had previously sent an email for Julie/Daniel
- Q) Darlene km 27 Barren Brook Road (owl survey route), young red pine cut and left
- A) Julie Punched out right of way anything cut out was utilized, if un-merchantable would have been left
- Julie and Daniel Y. logged off

 - Darlene stage 3 requesting more detailed map hwy 502 rookery and where harvest is in relation to nests. Dave stated Herons back on hwy 599
 - Dave will send Darlene basemap with that area
 - Michelle map not to be shared, LCAC info only
 - Dave logged off

c) MNRF General Updates (Michelle)

- Staffing
 - Catherine Dashnay will be returning from maternity leave on June 17th. She will be acting for a short term (1 month) as District Planner before returning to her Lands & Waters Technical Specialist role.
 - Ryan Helbing will be returning to his Resource Management Technician role as of June 17th.
 - District vacancies: District Planner, Resource Management Technician (Dryden),
 Resource Management Technician (Ignace), and Resource Liaison Specialist.
 - Province wide Summer students & Stewardship Youth Ranger program was cancelled this year due to on-going COVID-19 situation and staff having to work remotely from home.

District Initiatives

- During current COVID-19 situation District staff continue to work remotely from home, and focus is on critical business such as forest management planning
- Bearwise program has been deemed critical business and District continues to respond to calls logged in through the Bearwise hotline.
 - District was busy in the month of May with daily calls to the Bearwise hotline.
 - District sent an orphaned cub to a rehabilitation center in Nipigon.
 - Two bears were dispatched by home owners. One bear was a former orphaned cub that was sent to a rehabilitation center in Southern Ontario and was released back in the area in late October. Ear tags on the animal were collected for identification by the District.
 - One bear was trapped and released from the Harris Crescent area.

- o Due to COVID-19 most field work has been postponed at this point in time.
- MNRF staff currently reviewing the draft Dryden Forest FMP.

External Projects

- Watay line clearing still proceeding, and permits issued as necessary. Sioux Lookout District is the lead for this project.
- Q) Penny asked line clearing do they review any values (nests)
- A) Jill unknown
- A) Michelle will find out the answer

ACTION ITEM: Michelle to advise LCAC members if values (ie nests) are reviewed by the MNRF regarding the Watay line clearing.

- Q) Del asked Budworm spray that was cancelled was it due to COVID-19 health concerns or funding
- A) Michelle there already was funding large operations team safety not able to maintain social distancing, multiple districts with staff involved, 2-5 weeks would have brought people in from other areas
- Q) Del asked if MNRF will be monitoring what will happen with the Budworm infestation
- A) Michelle Planning to do aerial flights to look at extent of budworm infestation, foresters (from Forest Health) already looking on the ground collecting samples, will monitor rate of spread. Possibility of next year spraying.
- Q) Darlene asked if there will be maintenance of hiking trails at Blue Lake Park
- A) Michelle unknown, will have to consult with Steve Winsor, Parks Superintendent ACTION ITEM: Michelle to consult with Steve Winsor to confirm and advise LCAC if Blue Lake Park Hiking trails will have maintenance work performed. Completed (an email was sent confirming that trails were maintained and brushed by parks staff).

6. NEW BUSINESS/CORRESPONDENCE

- John received a letter from NW region re jackpine budworm. It did not have his name on it, simply LCAC but to his address. Post Office almost returned to sender but delivered. Issue with their mail out? Karen will investigate and advise Region. **Completed**
